RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/14195-20

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no. 1807/14195-20/15.04.2020 (ADA: ΩΞ78469B4M-008), published within the framework of the European Union funded research project **"INTELLIGENT, INTEROPERABLE, INTEGRATIVE AND DEPLOYABLE OPEN SOURCE MARKETPLACE WITH TRUSTED AND SECURE SOFTWARE TOOLS FOR INCENTIVISING THE INDUSTRY DATA ECONOMY (I3-MARKET)"**, project code **11320701 (position code 3207-PR1)**, for the implementation of the project:

In accordance with the decision of the 51st Meeting of the Research and Management Committee of RC/AUEB of the academic year 2019-2020, dated 17/06/2020 (ADA: 6Z68469B4M-Σ50), the application of the following candidate has been selected:

Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
