RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/46360-20

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/46360-20/18.12.2020 (ADA: ΨΑ4Λ469B4M-ΞΙΔ), published within the framework of the European Union funded research project **“AQUASPICE: ADVANCING SUSTAINABILITY OF PROCESS INDUSTRIES THROUGH DIGITAL AND CIRCULAR WATER USE INNOVATIONS”**, project code 11331301 (position code 3313-PR5), for the implementation of the project:

Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
