RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/17347-21

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/17347-21/28.04.2021 (ADA: 6ΘΞ0469B4M-Γ1Ζ), published within the framework of the European Union funded research project **"SMALL BUT PERFECTLY FORMED: ACCELERATING THE RISE OF CIRCULAR AND SUSTAINABLE SMES IN FASHION-SMALL BUT PERFECT"**, project code **11333801** (position code **3338-PR1**), for the implementation of the project:

- **Project Management (WP1).**
- **Creation of a transnational circular and sustainable fashion network and platform Methodology (WP2).**
- **Capacity building of fashion business support ecosystem Methodology (WP3).**
- **Acceleration and business support to SME led transnational projects in circular and sustainable fashion (WP4).**

Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
