RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/27193-21

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/27193-21/16.07.2021 (ADA: ΨΘΨ8469B4M-PKE), published within the framework of the European Union funded research project "ADVANCING BLACK SEA RESEARCH AND INNOVATION TO CO-DEVELOP BLUE GROWTH WITHIN RESILIENT ECOSYSTEMS - BRIDGE-BS", project code 11337701 (position code 3377-PR1), for the implementation of the project:

"Design and support the implementation of living laboratories in seven (7) case studies in the Black Sea, following a system innovation approach, and co-development of transformational pathways for blue growth (Blue Growth), in the context of work packages: WP1 (Knowledge base for the Black Sea), WP2 (Ecosystem dynamics under Multistressors), WP3 (Resilience for a healthy Black Sea Ecosystem), WP4 (Adaptive Management), WP5 (Smart observations and technologies for tackling multistressors, boosting innovation and supporting monitoring), WP6 (Socio-economics and social innovations), WP7 (Accelerating 'Industry 4.0' business models), WP8 (Science-based policy making for Blue Growth), WP9 (Education and Capacity Building), WP10 (Coordination and Management)"

In accordance with the decision of the 97th Meeting of the Research and Management Committee of RC/AUEB of the academic year 2021-2022, dated 01/09/2021 (ADA: 9ΠΙΧ469B4M-ΣΧΖ), the application of the following candidate has been selected:

Any objections to the results of the candidates' evaluation should be submitted strictly within a period of five (5) working days from the day following the announcement of the results on the website of RC/AUEB. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
