## RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/40383-21

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/40383-21/02.11.2021 (ADA:  $\Psi O\Omega Z469B4M-40Y$ ), published within the framework of the European Union funded research project **"SMART WATER FUTURES: DESIGNING THE NEXT GENERATION OF URBAN DRINKING WATER SYSTEMS-WATER FUTURES"**, project code 11336601 (position code 3366-PR1), for the implementation of the project:

"Research to develop new, innovative approaches to integrating risk and uncertainty into distinct selection experiments in the context of water safety under climate change with particular attention to results uncertainty, preferences and risk communication. The research development will be carried out in close collaboration with the members of Work Package 4 (WP4: Achieving Eudaimonia: a new theoretical and applied sustainable socio-economic framework) and the project partners in Work Packages: WP1 (Optimization-based Sequencing for Transitioning of Urban Water Systems under Deep Uncertainty), WP2 (Distributed Monitoring and Evolvable Control), WP3 (Explainable Machine Learning to support robust decision making by data-driven technologies), and WP5 (Water-Futures Research Toolbox and Case Studies), in different case study areas (Greece, Cyprus, Netherlands, Mexico). Where possible, similar research projects will be used to enhance the comparability of results and test their transferability over time, space and people, taking into account formal and informal water governance structures in all case study areas"

In accordance with the decision of the  $108^{th}$  Meeting of the Research and Management Committee of RC/AUEB of the academic year 2021-2022, dated 12/01/2022 (ADA:  $\Omega$ N37469B4M-YPO), the selection process produced no results.

Any objections to the results of the candidates' evaluation should be submitted strictly within a period of five (5) working days from the day following the announcement of the results on the website of RC/AUEB. Objections should be specific and should be submitted in person or sent by post to the address: 46, Kefallinias Street, Athens, 11251, Greece. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
