RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/22283-22

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/22283-22/08.06.2022 (ADA: 9ΝΣΧ469Β4Μ-ΒΟΑ), published within the framework of the European Union funded research project **“AQUASPICE: ADVANCING SUSTAINABILITY OF PROCESS INDUSTRIES THROUGH DIGITAL AND CIRCULAR WATER USE INNOVATIONS”**, project code **11331301 (position code 3313-PR7)**, for the implementation of the project:

“Design and Development of system and algorithms of combinatorial optimization for production in the context of Work Packages: WP4 (Digital Twin with Smart Analytics and Cognitive Services for Water Efficiency), WP5 (Water Cyber Physical System: The Industrial Water Efficiency Management System), WP6 (Demonstration and Evaluation of AquaSPICE Solutions), and WP8 (Communication, Dissemination, Training and Social Awareness)”

In accordance with the decision of the 127th Meeting of the Research and Management Committee of RC/AUEB of the academic year 2021-2022, dated 06/07/2022 (ADA: 62P7469B4M-02A), the application of the following candidate has been selected:

Any objections to the results of the candidates' evaluation should be submitted strictly within a period of five (5) working days from the day following the announcement of the results on the website of RC/AUEB. Objections should be specific and should be submitted in person or sent by post to the address: **46, Kefallinias Street, Athens, 11251, Greece**. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (ΑΠΔΠΧ 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
