RESULTS ANNOUNCEMENT-INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/49916-21

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/49916-21/17.12.2021 (ADA: P1KA469B4M-TΨM), published within the framework of the European Union funded research project **"SMART WATER FUTURES: DESIGNING THE NEXT GENERATION OF URBAN DRINKING WATER SYSTEMS-WATER FUTURES"**, project code 11336601 (position code 3366-PR5), for the implementation of the project:

"Participation in the design and conduct of experiments and questionnaires: in the laboratory, online or in the field. Analysis of the resulting data of behavioral theories (ambiguity aversion, loss aversion), finite rationality and heterogeneity (e.g. Quantal Response Equilibria, level-k), in the context of work packages: WP1 (Optimisation-based Sequencing for Transitioning of Urban Water Systems under Deep Uncertainty), WP2 (Distributed Monitoring and Evolvable Control), WP3 (Explainable Machine Learning to support robust decision making by data-driven technologies), WP4 (Achieving Eudaimonia; a new theoretical and applied sustainable socio-economic framework), and WP5 (Water-Futures Research Toolbox and Case Studies)"

In accordance with the decision of the 110^{th} Meeting of the Research and Management Committee of RC/AUEB of the academic year 2021-2022, dated 09/02/2022 (ADA: 9F8Ф469B4M-X5 Δ), the application of the following candidate has been selected:
