## RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR TWO (2) FIXED TERM RESEARCH CONTRACTS WITH REF. NUMBER 1807/52005-22

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/52005-22/29.12.2022 (ADA:  $\Psi KOII469B4M-3\Sigma \Phi$ ), published within the framework of the European Union funded research project "HUMAN BRAIN PROJECT (HBP) - SGA3", project code 11326901 (positions code 3269-PR5), under the supervision of the Scientist Responsible for the project, Professor Vasilios Vassalos, for two (2) Informatics Scientist positions, for the implementation of the project: "Contribution to Work Package (WP) 4 (task 4.19): Development of the MIP platform in HBP member hospitals. Contribution to the development of an automated subsystem for the curation and integration of biomedical data & (task 4.4): Workflow for the creation of anonymized versions of pseudoanonymized data stored on protected storages and their upload to the FENIX storage system. Adaptation of metadata registration and the curation and curation process of the anonymized data to pseudoanonymized data without leaking sensitive information)".

Pursuant to the provisions of articles 244 and 245 of Law 4957/20222 "New Horizons in Higher Education Institutions: Enhancing the quality, functionality and connection of H.E.I. with society and other provisions", and in accordance with the decision of the 152<sup>nd</sup> Meeting of the Research and Management Committee of RC/AUEB of the academic year 2022-2023, dated 22/02/2023 (ADA: <u>9П9B469B4M-E5X</u>), **the selection process produced no results.** 

Any objections to the results of the candidates' evaluation should be submitted strictly within a period of five (5) days from the day following the announcement of the results on the website of RC/AUEB, and until Monday the 13th of March 2023, at 16:00 (Local Time). Objections should only be submitted by sending an email to the following address: enstaseiselke@aueb.gr, and not later than the aforementioned closure date, otherwise they will not be accepted in order to be assessed. The Objections must be specific under penalty of inadmissibility. Additionally, any Objections to the results of a personal interview or an examination of knowledge or work competence and efficiency skills, will be considered as rejected. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (AIIAIIX 28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
