RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/43796-23

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no. 1807/43796-23/19.10.2023 (ADA: <u>60IП469B4M-X23</u>), published within the framework of the European Union funded research project **"PREDICTION OF RADIOTHERAPY SIDE EFFECTS USING EXPLAINABLE AI FOR PATIENT COMMUNICATION AND TREATMENT MODIFICATION (PRE-ACT)", project code 11350001 (position code 3500-PR2),** under the supervision of the Scientist Responsible for the project, Professor Iordanis Koutsopoulos, for one (1) Researcher, Post-Doctoral position, for the implementation of the project: *"Design and Implementation of Network Architectures for Web applications and Distributed Machine Learning, in the context of Work Packages (WP): WP3 (Explainable AI prediction models and AI platform development), and WP5 (Stakeholder co-design and communication package)"*.

Pursuant to the provisions of articles 244 and 245 of Law 4957/20222 "New Horizons in Higher Education Institutions: Enhancing the quality, functionality and connection of H.E.I. with society and other provisions", and in accordance with the decision of the 180th Meeting of the Research and Management Committee of RC/AUEB of the academic year 2023-2024, dated 01/11/2023 (ADA: <u>98Ψ7469B4M-317</u>), the application of the following candidate has been selected:

Objections should only be submitted by sending an email to the following address: enstaseiselke@aueb.gr, and not later than the aforementioned closure date, otherwise they will not be accepted in order to be assessed. The Objections must be specific under penalty of inadmissibility. Additionally, any Objections to the results of a personal interview or an examination of knowledge or work competence and efficiency skills, will be considered as rejected. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (A $\Pi\Delta\Pi X$ 28/2018).
