RESULTS ANNOUNCEMENT–INVITATION FOR EXPRESSION OF INTEREST FOR A FIXED TERM RESEARCH CONTRACT WITH REF. NUMBER 1807/23125-23

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/23125-23/26.05.2023 (ADA: <u> $\Psi3OH469B4M-\Omega8B$ </u>), published within the framework of the European Union funded research project **"DEVELOPMENT OF SOFTWARE MOBILE AD-HOC TACTICAL NETWORK DEVICES AND TESTBED (SMOTANET)"**, project code **11333401** (position code **3334-PR9**), under the supervision of the Scientist Responsible for the project, Professor Iordanis Koutsopoulos, for the implementation of the project: *"Implementation of resource allocation algorithms in software-defined wireless networks" WP3D - Final design of the SMOTANET systems"*.

The Objections must be specific under penalty of inadmissibility. Additionally, any Objections to the results of a personal interview or an examination of knowledge or work competence and efficiency skills, will be considered as rejected. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (A $\Pi\Delta\Pi X$ 28/2018).
