## RESULTS ANNOUNCEMENT-INVITATION FOR EXPRESSION OF INTEREST FOR TWO (2) FIXED TERM RESEARCH CONTRACTS WITH REF. NUMBER 1807/17250-24

The results of the candidates' evaluation are hereby announced following the invitation for expression of interest with ref. no 1807/17250-24/12.04.2024 (ADA: <u>Ε6Η1469Β4Μ-ΤΞΩ</u>), published within the framework of the European Union funded research project "RESONANCE-REPLICABLE AND EFFICIENT SOLUTIONS FOR OPTIMAL MANAGEMENT OF CROSS-SECTOR ENERGY", project code 11356001 (positions code 3560-PR3), under the supervision of the Scientist Responsible for the project, Professor George D. Stamoulis, for two (2) Researcher positions, for the implementation of the project: "Research in demand-side management mechanisms and in incentives' mechanisms for smart energy grids, in the application of these mechanisms (in software) in the pilots of project RESONANCE, as well as in the development and evaluation of related business models, in the context of Work Packages (WP): WP2 (Requirements and common system architecture design), WP3 (Resource Manager Catalogue), WP4 (Customer Energy Manager Catalogue), WP5 (Aggregation and sustainable replication support), WP6 (Piloting and validation of large scale replication), and WP7 (Impact creation) of the project".

Pursuant to the provisions of articles 244 and 245 of Law 4957/2022 "New Horizons in Higher Education Institutions: Enhancing the quality, functionality and connection of H.E.I. with society and other provisions", and in accordance with the decision of the 206<sup>th</sup> Meeting of the Research and Management Committee of RC/AUEB of the academic year 2023-2024, dated 15/05/2024 (ADA: <u>9XP6469B4M-05B</u>), the application of the following candidate has been selected:

Any objections to the results of the candidates' evaluation should be submitted strictly within a period of five (5) days from the day following the announcement of the results on the website of RC/AUEB, and until Wednesday, the 22nd of May 2024, at 16:00 (Local Time). Objections should only be submitted by sending an email to the following address: enstaseis-elke@aueb.gr, and not later than the aforementioned closure date, otherwise they will not be accepted in order to be assessed. The Objections must be specific under penalty of inadmissibility. Additionally, any Objections to the results of a personal interview or an examination of knowledge or work competence and efficiency skills, will be considered as rejected. Candidates who intend to exercise their legal right to the selection process and results, may, upon their written application, request access to the files and supporting documents of other candidates. The files/supporting documents submitted by the candidates are considered as their personal data, within the context of Article 4 of the General Data Protection Regulation 2016/679. Simultaneously, the same documents constitute administrative documents according to Article 5 para. 1 of the Code of Administrative Procedure, if and when they have been taken into account in shaping the relevant assessment procedure. Fulfillment of the right of access is possible under the conditions of the legislation on personal data and article 5 of the Code of Administrative Procedure and in accordance with the conditions that the Personal Data Protection Authority permanently accepts (A $\Pi\Delta\Pi X$  28/2018). Before submitting the data to the applicants, it is possible to inform the persons to whom this information refers. If the aforementioned deadline of the objections is not met, the results of this call for expression of interest shall become final.
